Sir/Madam

As directed by the Hon'ble Vice-Chancellor, UGB, and as has been decided in the examination monitoring committee, I am to inform you the following:

1. Tentative date of commencement of form fill-up of the eligible candidates and approval by the colleges (via online system at www.ugb.ac.in): June 11, 2018
2. Tentative date of commencement of on-line admit card generation: June 29, 2018
3. Tentative date of commencement of examination: Part I: July 13, 2018; Part II: July 12, 2018
4. Eligibility to appear in UG Part I and Par II Examinations 2018:
 - (a) The UGC guidelines 2015 will be followed.
 - (b) *Eligibility for Part I examination:* (i) Regular candidates (registration session: 2017-2018), (ii) Back candidates who got registration for the course in the session 2014-2015 (not earlier than the registration session 2014-2015 for any candidates); such candidates must complete their final examination in the year 2020 and no further back clearance will be allowed after the year 2020)
 - (c) *Eligibility for Part II examination:* (i) Regular candidates (registration session: 2016-2017), (ii) Back candidates who got registration for the course in the session 2013-2014 and either appeared in Part III examination 2018 or passed the Part III examination earlier; such candidates must complete their final examination in the year 2019 and no further back clearance will be allowed after the year 2019), (iii) Back candidates who got registration for the course in the session 2012-2013 and appeared in the Part III examination 2018, or passed the Part III examination earlier.

In view of the above, the authorities of all the affiliated colleges are requested to do the needful accordingly.
