- **SPECIAL TERMS AND CONDITIONS FOR TENDERS SUBMISSION**

- A) No advance payment shall be made at any circumstances.
- B) Payment will be made after 100% satisfactory delivery of computer equipments.
- C) Payment will be made through PFMS portal, Government of India. Successful bidder has to produce firm details and bank account in prescribed format for registration at PFMS portal.
- D) Conditional bid may not be accepted by the tender inviting authority.

- **PENALTY CLAUSES**
