- The documents are to be uploaded virus scanned copy duly Digitally Signed. The documents will get encrypted (transformed into non readable formats).
- O The Financial Bid of the prospective tender will be considered only if the Technical Bid of the bidder found qualified by the Principal/TIC, Dr. Meghnad Saha college. The decision of the Principal/TIC, Dr. Meghnad Saha College will be final and absolute in this respect.
- o Bid shall remain valid for a period not less than 90 (ninety) days after the dead line date for Financial Bid submission (As directed by the authority).





- Successful bidder shall have to sign an agreement in the Non-judicial stamp of Rs. 50/- and submitted security deposit @Rs. 2% of the total work value by Bank Draft/DCR within 7 days from the date of acceptance of tender, failing of which the e-tender submitted by him will be cancelled.

## SPECIALTERMS AND CONDITIONS FOR TENDER SUBMISSION
